**Conditions of licence: The Following shall be the conditions of the licence, namely:-**

- (a) The licence shall being the name of a specific person, for a specific business, place or places.
- (b) The licence shall not be transferable.
- (c) The licence shall limit his field of operation to the activity or activities for which the licence is granted.
- (d) The licence shall have at least one year's practical experience and professional know-how to run a travel agency, or he shall employ a professional qualified and experienced manager.
- (e) The licence shall employ experienced and trained staff for travel and tour operation work.
- (f) The licence shall be a citizen of Pakistan.
- (g) The licence shall obtain prior permission of the Controller if he desires to change his field of, operation branches and shall get his licence modified accordingly.
- (h) The licence shall promptly and immediately inform the controller of any change in the nature or composition of his firm to obtain his permission and get his licence endorsed accordingly or have a fresh licence issued to run the business.
- (i) The licence shall get his services charges approved by the Committee through the Controller and no change in such charges shall be made without the prior approval of the committee
- (i) The licence shall not charge for his services except in accordance with the rates approved by the committee.
- (k) The services charges duly approved by the committee shall be prominently displayed by the licences in this office premises and brought to the notice of the tourists and other clients concerned before entering into a contract with them.
- (l) The licence shall have a properly planned office in a suitable locality withy distinct and separate countries for booking passages, baggage or good by sea, air, rail or road, group tours, sight - seeing and entrainment booking with such other work facilities as may be desirable for the activities undertaken by him.
- (m) The licence engaged in group tours and sight-seeing activities shall employ on a regular basis sufficient number of licensed tourist guides duly trained at the tourism and hotel training institute of Pakistan.
- (n) The licence shall furnish any information in respect of his business that may be sought by the controller.
- (o) The Controller or an office duly authorized by him, shall have free access and right of inspection to the premises of the licences and his records.
- (p) The licenses shall quote the number of his licenses prominently in all his correspondence and commercial publications.
- (q) The licenses shall, within fifteen days of the grant of licenses, open a business guarantee fund under sub-rul (1) of rule - 14, or furnish a bank guarantee under sub-rule (2) of that rule failing which the licenses shall stand cancelled.
- (r) The licenses shall not carry out any business related to travel and tour operation work with any person or organization which does not held a valid licenses granted under the act.
