HAJJ 2027 – TERMS & CONDITIONS

Submission of this form constitutes a request for tentative enlistment only and does not guarantee confirmation of a Hajj booking. Final confirmation is strictly subject to:

- Official announcement of the Hajj 2027 Policy by the Government of Pakistan (GoP)
- Allocation of Hajj quota by the Ministry of Religious Affairs (MoRA)
- Submission of all required documents
- Receipt of full payment within the prescribed timelines

Booking confirmations will be processed strictly on a First Come, First Served basis once the official quota is announced.

HAJJ PACKAGE OVERVIEW

PACKAGE DURATION

- Total Duration: 14 Days
- Makkah (Aziziya): 10 Nights (4th – 14th Zilhajj) 10 May - 20 May
- Madinah (Markaziya): 3 Nights (14th – 17th Zilhajj) 20 May - 23 May

ACCOMMODATION ARRANGEMENTS

- Accommodation in Makkah Aziziya area on Full Board Basis. Three buffet meals daily in Makkah.
- Accommodation in Madinah Emaar Royal 4-Star Hotel (as per Saudi standards) in the Markaziya North area of Madinah. Approximately 250 metres from Masjid Al-Nabawi. Half Board Basis. (Closed to Bab un Nisa / Ladies Gate # 338-339)

ROOM SHARING POLICY

- Double, Triple, and Quad sharing options are subject to availability.
- Allocation will be confirmed on a First Come, First Served basis.
- Triple and Quad sharing may include additional beds in double occupancy rooms.
- Single travelers may be accommodated in Double or Triple sharing rooms.
- Quad sharing is recommended primarily for families.
- In shared accommodation arrangements, couples may be accommodated separately on a gender basis and rooms may be allocated on different floors, subject to hotel availability.

TENTATIVE ENLISTMENT FORM FOR HAJJ 2027 (1448 HIJRI)

MINA & ARAFAT ARRANGEMENTS

- Air-conditioned tents in Mina with separate arrangements for men and women.
- Two tents combined to accommodate up to 32 pilgrims.
- Air-conditioned marquee tents in Arafat with separate sections for male and female pilgrims.
- Each section accommodates approximately 150 pilgrims.

TRANSPORTATION ARRANGEMENTS

- Transportation will be provided through air-conditioned buses/coaches.
- Any private transportation or train bookings shall be arranged separately at additional cost, including Jeddah to Makkah, Makkah to Madinah, and airport transfers.
- A one-way shuttle service from Aziziya to Haram will operate on 5th, 6th, 7th and 13th of Zilhajj.
- Drop-off will be made at the nearest point permitted under Saudi traffic regulations.
- Return transportation from Haram must be arranged by pilgrims themselves through taxi services or by waiting for the return shuttle.
- During peak periods, waiting times may extend to approximately 2–3 hours.
- Pilgrims travelling from outside Pakistan may book their own train tickets during operational hours.
- On arrival at Jeddah airport Shared bus transportation to Aziziya accommodation may be utilized; however, delays should be expected during peak Hajj traffic periods.

PHYSICAL REQUIREMENTS & HEALTH ADVISORY

- During the core Hajj days (10th–12th Zilhajj), pilgrims may be required to walk approximately 37 kilometres over three days, particularly within Mina and Aziziya areas, due to transportation restrictions imposed by Saudi authorities.
- Wheelchair assistance is subject to approval by Saudi authorities and is not included in the package cost.
- Wheelchair services are generally available only in Makkah during Hajj days.
- Wheelchair handlers are not permitted inside Haram premises.
- Pilgrims requiring wheelchairs must arrange and bring their own.
- Golf cart and wheelchair services inside Haram may be available at additional cost.
- Expected temperatures during Hajj 2027 may range between 45°C and 50°C.
- Pilgrims are advised to take necessary precautions against heat and dehydration.

AIRLINE & TRAVEL POLICY

- Pilgrims residing in the UK, USA, Canada, Australia, Europe, Gulf countries, and other international destinations may purchase their own airline tickets if selecting a package without airfare (***no third party ticketing will be accepted like booking.com, skyscanner etc.***)
- Pilgrims travelling from Pakistan and selecting packages with airfare will travel through direct or indirect carriers according to package policy and availability.
- Hajj visa holders are not permitted to purchase Hajj tickets through the Saudi Airlines online portal. (as its Airline Policy to book direct through airline or any local agent in prescribe Hajj fare.)
- Pilgrims must comply with all Saudi Airlines Hajj travel regulations.
- Return travel on Saudi Airlines must be issued in the approved Economy Class “Y” fare category.
- One-way tickets from Pakistan are not permitted for Hajj visa holders travelling on Saudi Airlines.

TENTATIVE ENLISTMENT FORM FOR HAJJ 2027 (1448 HIJRI)

- Only return tickets are acceptable.
- Passengers arriving individually at Jeddah Terminal 1 or North Terminal may utilize train transfers, subject to operational availability. (by paying extra amount)
- Where train services are unavailable, private transportation may be arranged at additional cost.
- Pilgrims are advised to carefully follow all airline and travel instructions to avoid inconvenience or delays.

IMPORTANT CONDITIONS

- A formal Hajj Agreement and official Hajj application forms will be completed and signed at a later stage.
- The Company shall not be held responsible for circumstances beyond its reasonable control, including natural disasters, epidemics, pandemics, war, political disturbances, government restrictions, or operational disruptions.
- Once all payments have been submitted and the Hajj visa has been issued, all payments become strictly non-refundable under any circumstances.
- Any additional taxes, levies, fees, or charges imposed by the Government of Pakistan, the Kingdom of Saudi Arabia, airlines, or regulatory authorities shall be borne separately by the pilgrim.
- Gift items such as Ahram, trolleys, etc. will only be delivered within Pakistan via Daewoo Cargo Service, and will be available for self-collection.
- Vaccination arrangements: Expats will complete their meningitis vaccination in their respective countries through self-arrangement. Pakistani Hujjaj will be processed through the concerned Hajj Directorate as per official guidelines.

CANCELLATION POLICY

- Cancellations will be processed in accordance with the policies of the Ministry of Religious Affairs (Pakistan) and the Ministry of Hajj & Umrah (Saudi Arabia).
- The expected cancellation deadline is tentatively 20 December 2026, subject to official policy confirmation.
- After the permitted deadline, cancellation will only be possible through replacement by another eligible pilgrim arranged by the original applicant.
- Replacement requests must comply with accommodation sharing requirements, including same-gender replacement where applicable.
- All replacements remain subject to Nusuk Masar submission deadlines.
- If the Nusuk Masar platform ceases accepting entries, no further additions, replacements, or cancellations shall be permitted.

PAYMENT TERMS

- PKR conversion shall be calculated using the prevailing market selling rate published by Forex.com.pk on the date of payment.
- USD payments will only be accepted in the Company's designated USD bank account.
- In accordance with regulations issued by the Ministry of Religious Affairs and the State Bank of Pakistan, USD cash deposits within Pakistan are not accepted.
- USD cheque payments are not accepted.
- Applicants are advised to ensure timely payment through approved banking channels to avoid delays in processing.
